## EXTENSION OF THE DEADLINE FOR COMPULSORY DEMATERIALIZATION OF SHARES HELD IN PHYSICAL FORM.

With reference to above subject, the capital and commodity market regulator SEBI vide its circular No No. SEBI/LAD-NRO /GN/ 2018/49 dated 30<sup>th</sup> November, 2018 has extended the deadline for compulsory dematerialisation of shares held in physical form to April 1, 2019 from December 5, 2018.

Investors can continue to hold shares and securities in physical form even after the deadline, they will not be able to place the shares with the company or its registrar and transfer agent for further transfer after the deadline.
